Will of John Leach

In the name of God Amen I John Leach of the Township of Gallaway in the County of Atlantic and state of New Jersey being of sound mind and memory and understanding (for which blessing I thank God) do make and publish this my last will and testament in manner following that is - say

First it is my will and I do order that all my just debts and funeral expences be duly paid and satisfied as soon as conveniently can be after my decease.

Item I give and bequeath to my beloved wife Charlotte Leach the use of all my Real and Personal estate during her natural life

2. after the death of my wife my will is that the lot at Dolebeard hill be equally divided between my two sons Joseph Leach and Daniel Leach Joseph having the part on which his house now stands to them their heirs and assigns forever

3. I give and bequeath to my son Thomas Leach the house and lot on which I now live after the decease of his mother Charlotte Leach to him his heirs and assigns forever

4. I give and bequeath the residue of my estate to my grand son John Leach son of Joseph Leach to him his heirs and assigns

Lastly I hereby appoint Joseph Garwood my friend Executor of this my last will and testament,
