The last Will and Testament of Ellis Lewis I give to my wife Josephine Lewis for the term of her natural life the house and lot #302 South 40th Street in the City of Philadelphia being our present residence together with the household furniture books pictures this instrument and statuary, except the contained in the premises articles was made before herein otherwise disposed of. I also give to my wife for the term of her natural life the one third part of the residue of my estate These legacies and devises are in lieu and satisfaction of her right of dower and of the share which she would be entitled to under the laws concerning that she would prefer the provision herein made for her to that established by law, to my grandson Ellis Lewis Campbell I give one thousand dollars payable when he shall arrive at the age of twenty one years out of the residue of my estate I direct that the sum of one hundred dollars be released to Emanuel Marlein from the mortgage I hold against his house & lot I direct that upon the payment of all interest due at the time of my death on the mortgage which I hold against the house and lot occupied by George Bull and wife the said premises shall be discharged from the said mortgage I direct that the sum of one hundred and fifty dollars be paid to Theresa the Camberland and fifty dollars to Bridget the Cook for the extra trouble my long sickness has brought upon them I direct that my body be buried in my lot in Laurel Hill Cemetery and that an obelisk placed over the grave with such inscription and of such style as my daughter Josephine shall direct the maltese cross breast pin containing pearls and stones from the Pantheon the Palace of the Caesars St. Marks Church in Venice and a house in Pompeii I give to my daughter Josephine George Bull has had the use of my law library for a long time his professional services to me are to be received as compensation and on delivery of the books to my executors mental claims are to be considered settled no advancements are to be charged to any of my children except the sum of ten thousand dollars in Northern Central Rail Road Bonds to my daughter Juliet H. L. Campbell she will have the benefit of that sum without interest but to prevent injustice she may at her election have them valued and amount at the market value at the time of my death together with the interest she may have received the other children have had assistance and relief also but I do not deem it proper to take into account any advancement except the one already named all the residue of my real and personal estate I direct to be divided into four equal parts one part to go to my daughter H. L. Lewis

Campbell and her heirs another part to go to Mrs Annie Wiley and her heirs a third part to Miss Josephine Lewis and her heirs the remaining fourth part I direct to be invested in some safe corporation in trust to pay the semi annual interest to my son Major James Lewis and his wife Matilda during their natural lives and the life of the survivor upon their death the principal sum to be paid to my other children and their representatives upon the death of my wife the property devised and bequeathed to her for life is to be distributed among my children in the same manner as I have directed with the residue Hon James H. Campbell and my wife Mrs Josephine Lewis are appointed executors of this will with power to sell and convey real estate when it shall be deemed proper to do so January 17th 1870 Ellis Lewis January 18th 1870 The last will and testament of Ellis Lewis Contingent, In the estates distributed among my children as herein before directed I direct that the same be held in trust nevertheless so that upon the death of the said child and his husband without leaving any child living at the time of the death of the survivor the said estate shall go to my other children upon the same terms and in case of their death at the time the estate rests then it is to go to my grand children to be equally divided between them this clause has no reference to my son Major James Lewis whose interest is specifically provided for in trust as a memorial of affectionate regard for the following named persons I give to my daughter Juliet H. L. Campbell and her heirs forever my pew in St Stephens Church in 10th Street between Market and Chestnut I give to my daughter Annie Wiley the large silver pitcher presented to me by my dear friend W. B. Morehead late President of the Philadelphia and Erie Rail Road Company in consideration of the advice and aid rendered by me to him in the construction of that important work I give to my daughter Josephine Lewis a new Piano and direct that the old one be sold and a new one purchased for her by adding to the proceeds of the old one as much money as shall be necessary for this purpose I give to my son Major James Lewis the gold watch which I have carried for nearly forty years together with the key & gold chain I give to my grand son Ellis L. Campbell in addition to the pecuniary legacy already mentioned my large gold watch seal with my monogram cut in the stone seal of the same together with my coral breast pin silver wood sleep buttons and studs mounted in gold I give to my grand daughter Juliet H. L. Campbell the large silver ice cream knife presented to me by Cousin Margaret P. Lewis knowing how she loves julie she will appreciate this disposition of the present which I can no longer enjoy also I give to said julie the picture of the Madonna in the north east corner of the parlor unless my daughter Annie takes it to the Birth of the Virgin which I give her with the rest of the furniture and valuable and useful and interesting possessions in the house
