Keep out of Debt, Live within your means, Love one another, Bear, and Forebear, with the weaknesses of each other. be Forgiving more are perfect. and may that Kind God; who has watched over me from Infancy to Boyhood, and manhood, and old age, Protect and care for you all, while you live, and may we all meet where there is no more sorrow or care or pain, with our Heavenly Father. In witness hereof I hereunto set my hand and seal. This Eighth Day of May in the year of our Lord 1882, Eighteen Hundred, and Eighty Two, in the presence of the subscribing witnesses and of each (other) Between lines seventeen and eighteen, on Page 1 opposite side.
