Item, I nominate and appoint my said wife Mary Ann Piersol Testamentary Guardian of my Minor Children during their respective minorities,

Item, I nominate, constitute and appoint my Sons William H. Piersol and Joseph N. Piersol my Executors and Trustees of this my last Will and Testament, and I do hereby authorize direct and empower them my Said Executors and Trustees by and with the consent and approbation of my said wife Mary Ann Piersol signified by her joining in and becoming a party to any Deed of conveyance or other instrument of writing at any time after my decease that they may deem proper and advantageous to my Estate to sell and dispose of all or any part of my Real Estate either at public or private sale for the best price that can be reasonably be had or gotten for the same, and to grant and convey the same or any part thereof unto the purchaser or purchasers thereof his, her or their heirs and assigns forever, without any liability on the part of the purchaser or purchasers thereof or their heirs or assigns to all the proper application of the purchase money.

Lastly - I hereby by revoke all former Wills by me at any time made and declare this only to be and contain my last Will and Testament.

Whereas, by the said Item of this my Will, I do authorize and direct my said Executors and Trustees herein named to place and continue my personal Estate at Interest-on-Bond and Mortgage or against the same in State or City Loans or Funds. Now I do will that said direction shall not apply to the Stock of the Mount Farm Coal and Oil Company of West Virginia, I now hold, but that said Stock shall remain as it now is or may be disposed of by my said Executors and Trustees at their discretion and that the Interest and Income thereof or the proceeds realized from the sale thereof shall be applied and appropriated as provided in said Item regarding my Residuary Estate and I do hereby exonerate my said Executors and Trustees from all liability of loss sustained by reason of my depreciation of said stock.
