Fourth, I leave nothing to my Daughter Celestina Abrioli, married Luigi Stoppelli, as she received every- thing due to her at the time of her marriage, and she will not compete for the legacy left by me at my death.

My funeral will be done honorably and the expenses of the same will be divided as follows, my son Saverio with four parts and the other two sons, Michael and Joseph with one part each.
