

alike - In the event of either of said grand children dying either in my lifetime or after my decease, before the arrival of the younger at the age of twenty five years then said net income, shall be paid over to said Ida C. Mustin for the maintenance education and support of the survivor until he arrives at the age of twenty five years at which time two thirds of said principal sum of Forty thousand (40000) Dollars shall be paid to said survivor and the remaining one third to his mother the said Ida C. Mustin. In the event of both of said grand children surviving their mother and living until the younger arrives at the age of twenty five years I then direct that said principal sum of Forty thousand (40000) Dollars shall be paid over to them share and share alike on the arrival of the youngest at the age of twenty five years. In the event of both of said grand children dying, either in my lifetime or after my decease, before they arrive at the age of twenty five years leaving their mother the said Ida C. Mustin to survive them I then direct the whole of the net income of said principal sum of Forty thousand (40000) Dollars to be paid over to their said mother for and during the term of her natural life and on her decease said principal sum to be paid to such person or persons then living who would be entitled to my Estate and in such shares as they would be entitled to the same under the intestate laws of the Commonwealth of Pennsylvania had I died intestate at that time. In the event of both of said grand children surviving their ^{said} mother and dying either in my life time or after my decease before the arrival of the younger at the age of twenty five years I direct said principal sum of Forty thousand (40000) Dollars to be paid on the death of the survivor to such person or persons then living who would be entitled to my estate and in such shares as they would be entitled to the same under the intestate laws of the Commonwealth of Pennsylvania had I died intestate at that time. If only one of said grand children shall survive his said mother and arrive at the age of twenty five years I direct the whole of said principal sum of Forty thousand (40000) Dollars to be paid to him on his arrival at the age of twenty five years. It is my will and direction that said principal sum of Forty thousand (40000) Dollars shall be kept together as a whole and shall not vest in either of them or be distributed until the younger

of said grand children or the survivor of them shall arrive at the age of twenty five years as above provided. To hold another one third part or Forty thousand (40000) Dollars of said sum of One hundred and twenty thousand (120,000) Dollars for Margaret Mustin widow of my son William F. Mustin deceased and her children Sarah W. and Mary F. Mustin under and subject to the same terms limitations and conditions as above provided in the case of said Ida C. Mustin and her children Henry C. and J. Burton Mustin.

To pay over the net income of the remaining one third part or Forty thousand (40000) Dollars of said sum of One hundred and twenty thousand (120,000) Dollars to my son Charles F. Mustin for and during the term of his natural life and on his death to pay over the principal thereof unto such person or persons then living who would be entitled to my estate and in such shares as they would be entitled to the same under the intestate laws of the Commonwealth of Pennsylvania had I died intestate at that time. In all cases ^{where} I have heretofore directed income to be paid to any person or persons it is my will and I direct that it shall be paid to them free and clear of all liability for the debts, contracts and engagements of said person or persons.

IV. If after the payment of said legacies to said Anna F. Willard and Mary F. Bennett and the setting aside of said sum of One hundred and twenty thousand (120,000) dollars there shall remain in the hands of said Trustees any balance of said rest and residue of my estate I direct said Trustees to pay over the following legacies: To my niece Anna Bennett the sum of One thousand (1,000) Dollars

To my nephew John M. Finn the sum of One thousand (1,000) Dollars, from which sum is to be deducted any sum of money due by him to me.

To my nephew William W. Finn M. D. the sum of One thousand (1,000) Dollars. To my half sisters Mary Whiteside and Bessie Lynch the sum of One thousand (1,000) Dollars each.

To Florence and Helen Budd children of my half sister Cornelia Budd deceased the sum of Five hundred (500) Dollars each. To my half brother C. Beneger Mustin the sum of One thousand (1,000) Dollars.

To my cousin Sallie B. Deboear who has been in my employ for a number of years the sum
