Fiske deceased, Now Therefore if the above bounden Emma Fiske administratrix aforesaid, do make or cause to be made a true and perfect inventory of all and singular the goods chattels and credits of the said deceased, which have or shall come to the hands, possession or knowledge of the said Emma Fiske or into the hands or possession of any other
