

Evening for the delivery of goods only with the assistance of one of my family and some good and competent person in charge the whole amount of my Capital and interest shall be invested in some sound interest paying securities if received at one time or as soon as the amount collected in the store shall reach over one thousand dollars the same shall be invested and so on until the whole of my stock shall be delivered or sold and the money securely invested.

Third, I order and direct that my interest in the store at the South east corner of Sixth and Race Streets in the City of Philadelphia shall be carried out according to certain articles of agreement entered into between me and Abraham J. Mac Garry cash of us having a copy of said agreement and all monies received on account of my interest in said store shall be invested in some sound interest paying securities and for the better protection of all notes bonds mortgages and other securities belonging to my estate I direct my executor at the expense of the estate to rent a safe in some safe deposit Company vaults wherein they shall place all such securities.

Fourth, I give devise and bequeath unto my wife Sarah Harvey all my estate real personal and mixed of whatsoever kind and wheresoever situate for and during all the term of her natural life she paying all taxes and water rents ground rents and other charges against the same and to keep the real estate in good repair tenantable condition and after the death of my wife I make the following divisions or distribution of my entire estate to wit:

Fifth, I give devise and bequeath unto my daughter Fanny Abrahamus my two lots of ground and premises Nos. 429 and 431 South Second Street in the City of Philadelphia for and during all the term of her natural life she to pay all taxes water rents and other charges against the same and to keep said premises at all times in a good and tenantable condition and at her death I give devise and bequeath the said premises unto her children who may then be living their heirs and assigns in fee, share and share alike I also give devise and bequeath unto my said daughter Fanny Abrahamus her heirs and assigns my lot of ground situate in Atlantic City State of New Jersey and also the sum of seven thousand dollars in Cash absolutely and I direct my Executors to cancel the note of two thousand dollars which I hold

against my said daughter Fanny Abrahamus.
Sixth, I give devise and bequeath unto Samuel Abrahamus his heirs Executors and administrators my large gold headed walking cane which he presented to me the picture of Sallie Solomons Benjamin Levy and his Brother Lew and of Joseph Cowan.
Seventh, I give devise and bequeath unto my daughter Rebecca Weil my two lots of ground and premises one of them situate at the South west corner of Fourth and South Streets and the other No. 606 South Fourth St. adjoining the first lot of ground on the south in the City of Philadelphia for and during all the term of her natural life she paying all ground rents and all other charges against the same and to keep said premises at all times in good tenantable condition and at her death I give devise and bequeath the said premises unto her children who may then be living their heirs and assigns in fee share and share alike I also give devise and bequeath unto my said daughter Rebecca Weil the sum of seven thousand dollars in cash absolutely.

Eighth, I give devise and bequeath unto my daughter Katie Hillbrommer my two lots of ground and premises situate on the South side of South Street No. 1816 and 1818 extending through to Kator Street and also my lot of ground and premises situate on the east side of Dilwyn Street No. 539 all in the City of Philadelphia for and during all the term of her natural life she paying all taxes water rents and all other charges against the same and to keep said premises at all times in good tenantable condition and at her death I give devise and bequeath the said premises unto her children who may then be living their heirs and assigns in fee share and share alike I also give devise and bequeath unto my said daughter Katie Hillbrommer the sum of seven thousand in cash absolutely.

Ninth, I give devise and bequeath unto my daughter Tillie Singer my four lots of ground and premises No. 336 South Street No. 326 and 327 Front Street and No. 1228 Catharine Street and the premises in the rear No. 1229 Thurston Street in the City of Philadelphia for and during all the term of her natural life she paying all ground rents taxes water rents and all other charges against the same and to keep said premises at all times in a good and tenantable condition and at her death I give devise and bequeath the said premises unto her children who may then be
