

for Insurances on Lives, &c., located at 317 Chestnut Street, Philadelphia, to be by them held in trust and the said principal and interest thereof invested and re-invested, and allowed to accumulate during the minority of the hereinafter mentioned children, and a proportionate share of the principal and its accumulations be paid over to each of the four children of the said Dr. W. H. King, as such children shall severally arrive at the age of twenty-one years. In case of the death of any of the said children under said age, the share of the one so dying shall be divided among the survivors attaining the age aforesaid. Item: I give to H. Lazelle King, now in Manila, the sum of Twenty-five Hundred Dollars, (\$2,500.) absolutely. Item: I give to Mrs. Anita K. Carter the sum of Twenty-five Hundred Dollars (\$2,500.) absolutely. Item: I give to Mrs. Annie Mathews, now living with me, the sum of Fifteen Hundred Dollars, (\$1,500.) absolutely. Item: I give to Laurel Hill Cemetery Association, located near Philadelphia, Pa., the sum of Five Hundred Dollars, (\$500.) to be by it invested and the income arising therefrom to be employed in keeping the family burial lot in good order and condition. Item: I give unto the Women's Board of Foreign Missions, of the Presbyterian Church of North America, the sum of Five Hundred Dollars, (\$500.) and to the Board of Home Missions of the Presbyterian Church of North America, a like sum of Five Hundred Dollars, (\$500.), the same to be applied to the work of the Women's Board; and to the Board of Ministerial Relief, of the Presbyterian Church, the sum of Three Hundred Dollars, (\$300.); and to Park College, located in the state of Missouri, the sum of Three Hundred Dollars, (\$300.); and to the Mariners' Church of Philadelphia, Front and Delancy Streets, the sum of Two Hundred Dollars, (\$200.); and to the Women's Christian Temperance Union of Chester, Delaware County, Pennsylvania, the sum of Fifty Dollars (\$50.); and to the Women's Christian Temperance Union of Atlantic City, N. J., the sum of Fifty Dollars (\$50.); and to Miss Kate McDermott the sum of Two Hundred Dollars, (\$200.). Item: All of the said legacies to be paid to the aforesaid legatees without deduction for any taxes assessed by national or state authority. Item: All the rest, residue and remainder of my estate, real, personal or mixed, I give, devise, and bequeath to J. Evertor Ramsey, of Oxford, Chester County, Pennsylvania, in trust, that he shall dispose of the same as

follows, to wit: That he shall pay out of said residue, within two years after my decease, the sum of Five Thousand Dollars, (\$5,000.), to each of the following four named beneficiaries, to wit: To the Women's Board of Foreign Missions of the Presbyterian Church of North America; to the Board of Home Missions, of the Presbyterian Church of North America the same to be applied to the work of the Women's Board; to the Board of Ministerial Relief of the Presbyterian Church, and to the aforesaid Lincoln University; if said residue shall be insufficient to pay said legacies in full, then each of said beneficiaries shall share pro rata therein, and if any estate shall then remain, I give, devise and bequeath the same absolutely to the said J. Evertor Ramsey, in consideration of his services rendered to me in the settlement of the estate of my late husband and as his compensation for his services rendered me in the management of my estate. I direct, however, that he shall deliver over to such persons as I shall name, in a writing which I shall leave, my trinkets, jewelry, household goods, pictures, bric-a-brac, statuary, plate, silverware, books and articles of such like nature. And lastly, I nominate, constitute and appoint the said J. Evertor Ramsey, sole executor of this, my last Will and Testament, and if in conformity to law, he shall not be required to give any security for the performance of this trust, and I authorize and empower him to sell and dispose, by good and sufficient deed or deeds, in fee simple of any real estate, wheresoever situate, that I may be seized and possessed of without any liability on the part of the purchaser to see to the application of the purchase money.
