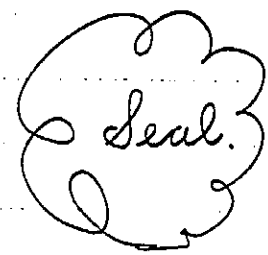
In the matter of the Probate of the alleged Will of Elizabeth Jang deceased } Order For Probate.
