

In the event of the death of any of my said children before my de-

Fifth: I hereby give to my Executor and Trustee hereinafter named for
his full consideration for the execution hereby imposed upon him
the same consideration as is now allowed for the services herein
required by the laws of the State of New York, to be computed on
all of the property real and personal hereby given to him in
trust wherever situate.

Sixth: All the rest, residue and remainder of my property, both real
and personal, I give, devise and bequeath to my beloved wife Susan
B. Perison, to have and to hold for her own use and behoof for
ever.

Seventh: I hereby nominate, constitute and appoint my friend Thomas
D. Rambaut, of the Town of Easttown, Richmond County, New York, to
be the Executor of and Trustee under this my last Will and
Testament.

this my last Will and Testament written on four pages of
paper set my hand and seal this twenty-seventh of April,
in the year one thousand eight hundred and ninety nine.
