In the matter of the probate of the last will and testament of James M. Moore deceased. } Order For Probate.

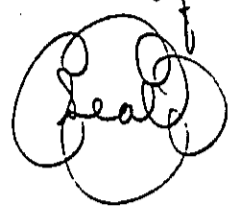
