profits arising from my estate both real and personal, and I direct my executor, after the decease of my daughter Ella C. Doughty to pay the portion of the net income and profits which would have gone to my said daughter, were she still living, to her children equally, share and share alike, until her youngest child living at the time of my decease shall have attained the age of twenty one years, and when such child shall have attained the age of twenty one years, I direct my executor hereinafter named to convey to her issue share and share alike by good and sufficient deed, assignment or transfer, or to sell my said estate and pay to said issue, share and share alike the portion of my estate from which my daughter Ella C. Doughty would have received the income and profits, if she were then living.

Seventh.- It is my will and I hereby direct my executor hereinafter named, to pay to my daughter Mame H. Ryan during the period of her natural life the full and equal one third part of the net income and profits arising from my estate, real and personal and it is my will and I hereby direct my executor, after the decease of my said daughter Mame H. Ryan, to pay the portion of the net income and profits which would have gone to my said daughter, to her children equally share and share alike, until

her youngest child living at the time of my decease shall have attained the age of twenty one years, and when such child shall have attained the age of twenty one years, I direct my executor, hereinafter named, to convey to her issue share and share alike by good and sufficient deed, assignment or transfer, or to sell my said estate and pay to said issue share and share alike the portion of my estate from which my daughter Mame H. Ryan would have received the income and profits, if she were then living.

Eighth.- It is my will and I hereby direct my executor hereinafter named, that in the event of my wife electing to take her common law dower instead of the gifts and bequests hereinafter provided for her, then in that event I direct my said executor to pay the net income and profits arising from my personal estate to my said daughters Ella C. Doughty and Mame H. Ryan equally, share and share alike in the same manner and subject to the same provisions as are contained in the two preceding sections. I further direct that in the event of my wife electing to take her common law dower, that the rest and residue of my real estate after her dower shall have been assigned to her, shall vest in John F. Ryan my executor hereinafter named in trust for my daughters Ella C. Doughty and Mame H. Ryan and their and each

issue as provided in sections sixth and seventh.

Ninth.- After the decease of my wife Amelia S. Ireland or at the termination of her widowhood, it is my will and I hereby direct my executor, hereinafter named, to pay the portion of the net income and profits hereinafter directed to be paid to her; or if she elect to take her common law dower, then the lands so assigned to her at her decease shall vest in John F. Ryan my executor hereinafter named and said income or profits from said real estate, or the net income and profits hereinafter stated in this section shall be paid to my said daughter equally, share and share alike in the manner and subject to the provisions contained in sections sixth and seventh.

Tenth.- It is my will and I hereby direct my executor hereinafter named that in the event of the death of my daughter, Ella C. Doughty without leaving lawful issue, that he, my executor, shall pay the portion of the net income and profits hereinafter directed to be paid to my said daughter Ella C. during the period of her natural life, to my daughter Mame H. Ryan and her heirs in manner provided in clause eighth, and in the event of my daughter Mame H. being then deceased without leaving lawful issue, then in that event I order and direct that the aforesaid portion of the income and profits be paid to my wife Amelia S. during her widowhood. I further order

and direct that should the said portion of my income and profits not vest in the issue of my said daughter Ella C. nor in my daughter Mame H. or her issue, nor in my said wife Amelia S. according to the foregoing provisions then in that event I give and devise the said portion of my income and the estate from which it arises to my son-in-law John F. Ryan in fee and absolutely.

Eleventh.- It is my will and I hereby direct my executor, hereinafter named, that in the event of the death of my daughter Mame H. Ryan, without leaving lawful issue, that the portion of the net income and profits, hereinafter directed to be paid to her during the period of her natural life, shall be paid to my son-in-law John F. Ryan during his lifetime and at his decease to go to and be paid to my daughter Ella C. Doughty in manner provided in clause sixth aforesaid.

Twelfth.- It is my will and I hereby direct that in the event of the death of my wife Amelia S. and of my daughters Ella C. Doughty and Mame H. Ryan without leaving lawful issue of either of my said daughters, then in that event, I give and devise my estate real and personal to my son-in-law John F. Ryan in fee and absolutely.
