Fifth: I hereby authorize, empower and direct my executor hereinafter named, out of the proceeds, of my estate to erect, construct and maintain in some suitably locality or places in the City of Philadelphia, as in his judgment may seem best, a public fountain for either drinking or ornamental purposes, the approximate cost or such construction to be Five thousand (\$5000) Dollars.

The character and design of such fountain I leave to the sound judgment and discretion of my said executor. The said gift, however, is accompanied with the direction that is shall bear the inscription in plain legible words "Erected to the memory of Theodore P. Matthews) o or some other appropriate reference to the memory of my deceased husband as may deem best and proper in the wisdom of my said executor.

Sixth: I herein request my firstends. Mrs Lilliam Woolman and Mrs Clara Irick, to distribute my personal clothing and effects to and among such persons as they may deem entitled to receive discretion and power in the making of such distribution.

Seventh: I give: devise and bequeath all the rest, residue and remainder of my estate, real and personal, of whatsoever, nature or kind and wheresoever the same may be, unto Rebecca Hemp hill, Clara Hemphill and Peggy Hemphill, daughters of my cousin by adoption, Rebecca Mickle Hemphill, wife of E Dallett Hemphill, of West Chester, Pennsylvania in equal parts or shares, the personal estate to them absolutely the real estate to them, their heirs and assigns forever.

Eighth: I hereby authorize and empower my Executor here inafter named to sell my real estate or any part thereof at public or private sale or sales for such price or prices and upon such terms as to him shall seem expident, without any obligation on the part of the purchaser or purchasers thereof to see to the application of the purchase money or moneys received therefor.

Ninth: I t is my Will that no Inventory of my estate shall be filed by me Executor hereinafter named and that he shall not be required to file or settle any account of the administration by him of my said estate.

Tenth: I nominate constitute and appoint Alexandern M. DeHaven, EEsquire, a dear friend of my late beloved husband, to be the Executor of this my said Last Will and testament.

BE IT REMEMBERED that I, Julia T. Matthews, of the City of Philadelphia, widow of Theodore P. Matthews, being of sound and disposing memory and understanding, do herein and hereby make and declare the following as and for a codicil to my above and foregoing Will, bearing even date herewith, in manner and form, to wit:-

First as to the fifth item of my said will, I direct that the sum of Two thousand dollars (\$2000) for so much thereof as my Executrix may deem necessary) be set apart out of my residuary estate by my Executor and Trustees mentioned in my said will, the income of which money shall be expended toward supplying ice, during six months of the year, for

drinking purposes or repairs in connection with the Fountain therein referred to.

Second. As to the sixth item in my sAid will, I give and bequeath unto my friend Lillian Woolman my large India shawl, and to my friend Clara Irick any particular article of personal clothing, effect or jewelry that i may leave that best pleases her desire or fancy, of equal value to the India shawl given my friend Lilliam Woolman. I wish these two friends of mine to keep and retain those arcticles as mementoes of the dear bonds of firiendship which have existed between us for so many years.

Third: I give and bequeath absolutely and in fee unto my friend Alexander M. DeHaven the certain Lehigh Valley Railroad Company Four Per Cent (4%) General Consolidated Mortgage Bond, number A 255, in the sum of One thousand dollars (\$1000), now owned by me, bearing date of August 14,1905; and if the said bond shall be paid off before the time of my decease, then I give unto him a like sum of One thousand dollars (\$1000) in cash. I make this specific bequest as a mark of my personal respect and friendship for him, and in memory of the friendship which always existed between him and my deceased husband, Theodore P. Matthews-

Fourth. I hereby revoke the devise and bequest of the residue and remainder of my estate as mentioned and set forth in item seven of my said Will unto Rebecca devise and bequeath all the rest, residue and remainder of my estate, real and personal of what soever nature or kind and where soever the same may be situate, as follows: Unto each of the aforesaid Rebecca Hemphill, Clara Hemphill (now Clara Davis) and Peggy Hemphill ( now Peggy Williamson), the sum of Fifteen hundred dollars (\$1500) in cash, free and clear of all taxes. Of the balance of my said residuary estate, I give, devise and bequeath the sum of Two hundred dollars (\$200) to the Society for Prevention of Cruelty to Animals, located at 1627 Chestnut Street, Philadelphia, in memory of my two animal pets, the sky terrier "Fritzie" and the cat "diavola". The balance of my said estate, whether coming from hithe sale of the premises 707 Chestnut Street, Philadelphia now owned by the Tyndale Estate in which I am interested, or elsewhere, shall then be divided equally between the University of Pennsylvania, to be applied to the sustemance and maintenance of the "Hector Tyndale Chair for the Foundation of "Physics", and the Hahnemann Hospital, located at Fifteen and Race Streets, Philadelphia, to be applied for the maintenance and care of a bed or room therein which shall be designated, described and known as "In memory of Theodore PLMatthews", deceased".

Fifth. Should the funds received from my said residuary estate not be sufficient to adequately carry out all of the bequests made in the foregoing fourth item of the Codicil to my Will, then I direct that the discretionary power shall be lodged in my said Executor to select which of the items therein referred to shall abate or be entirely dispensed with.

Sixth. In all other respects I hereby ratify, confirm, publish and declare my foregoing will to be in full force and effects, except as altered, changed and annulled in any by the terms of this my Codicil thereto.
