## Will of Elenore Jagmetty

I, Elenore Jagmetty of the city of Atlantic City county of Atlantic and State of New Jersey, do make, publish and declare this my last will and testament as follows, that is to say: Item 1-I direct that my executors hereinafter named pay to my son Victor Jagmetty the sum of Six Thousand and Six Hundred dollars being due him for expenditures made by him for alterations and improvements made in and to my premises No.22 South Tennessee Avenue in the city of Atlantic City aforesaid as well as pay him for such other sums of money as he may expend for future necessary repairs and alterations in and to said premises, as evidenced by proper vouchers. Such sum or sums with interest are to be taken in full satisfaction and discharge of any claim or lien held by him on or against said premises. item 2- I direct that my said executors shall pay to the Pleasantville Cemetery Association the sum of one hundred dollars annually for three years, or in toto the sum of three hundred dollars, to be held by said Association as a trust fund to be invested in some substantial interest bearing security and to use the income therefrom for the up-keep of my family burial lot in said cemetery. However, should said burial ground of said cemetery be abandoned said Association is to defray the charges of the removal and reinterment of the members of my family therein buried. Should said Pleasantville Cemetery Association decline said trust then my executors shall select some other person or corporation as trustee for the purposes eforesaid.

Item 3-I give, devise and bequeath unto my sons Victor, Joshua and Charles, each, a one sixth share of my estate absolutely, subject to the foregoing items.

Item 4-I give, devise and bequeath unto my executors hereinafter named the residue of my estate, both real an-opersonal, In Trust to sell and dispose of the same as them may seem meet and proper without obligation on the part of the purchaser or purchasers to see to the application of the purchase money, and to invest the proceeds thereof in good and substantial revenue yielding property or securities, and from such income pay to my son Joseph Jennings and daughter Alice Jagmetty a one third share, each, annually for life; however, in the event of the illness of either such reasonable sums are to be allowed from the principals yielding such incomes as may be necessary for the proper care of such one as well as for interment in case of death. The remaining one third share is to be paid by my said executors for the support of myinvaled daughter Angelina Fox in such institution in in the State of New Jersey or Pennsylvania as they may select.

Upon the death of either of my said children Joseph Jennings, Alice Jagmetty and Angelina Fox a one third share of my said residue estate representing the revenue yielding principal of such one of my said children as may be deceased shall be divided among my heirs and next beneficiary or of kin according to law, provided however the sharet as may proceed therefrom to the surviving beneficiaries of the trust hereby created are to be subject to the provisions of such trust; and provided further, that upon the death of my said daughter Angelina Fox, the sum of Twelve Hundred dollars is paid from the principal yielding the proceeds for her support as aforesaid to my son Victor Jagmetty in recompense for moneys expended by him on account of the support and maintenance of my said daughter. It is my request that upon the death of my said daughter Angelina Fox, my executors make some donation to the institution caring for her from the principal yielding the income for her support and maintenance as heretofore provided.

Item 5-I nominate, constitute and appoint my sons Victor, Joshua and Charles Jagmetty executors of this my last will and testament.
