And at the death of my said husband, I direct that the said jewelry shall be sold by the executors of my Will, or their successor, at public or private sale, and the proceeds thereof paid in equal shares to the Sheltering Arms of the Protestant Episcopal Church in the City of Philadelphia, and the Day-Kimball Nursery at Putnam Connecticut, for a free bed or beds in the latter institution.

Fourth: I give and bequeath my ruby and diamond ring, my emerald ring, my turquoise ring, my small diamond-back watch with chain, my Louis XV silver tea service, the bust oil sketch by David Bani of my portrait, and my Welte player -piano now at my country house at Pomfret, Connecticut, to my sister Marion L. Harvey.

I give and bequeath my antique sapphire ring to Mrs. (Louise Harrison) J. Wilson Patterson, of Baltimore.

Fifth: I give and bequeath my silver melon shaped tea service to my husband Thomas Skelton Harrison, absolutely, should he survive me, but should he die before me, then I give and bequeath the same to John Harrison, son of the late Charles Leland Harrison, and in case of his deceased before me, to my sister-in-law Eliza H. Elliot with the request that at her death she bequeath said tea service to L. Harrison Dulles. If neither my husband nor any of the said John Harrison, Eliza H. Elliot or L. Harrison Dulles, survive me, then I direct that the said silver tea service shall be disposed of as part of my residuary estate.

Sixth: I give and devise my two houses, Nos. 1518 and 1520 Locust Street Philadelphia, (one of which No. 1520 I now occupy as my residence) my country seat at Pomfret, Connecticut, and also my other property at Pomfort, Connecticut, formerly occupied by the Pomfret Club, with all the books, pictures, furniture, miniatures, plate, household implements, china, glassware, works of Art, bedding, linen and personal chattels and effects whether useful or ornamental, to my husband Thomas Skelton Harrison, should he survive me, but should he not survive me, then I give and bequeath to the Pennsylvania Museum and School of Industrial Art, such of the contents of my said residences (except the jewels), as the said school may select, to be kept and held on free perpetual exhibition at Memorial Hall in Fairmount Park, Philadelphia, to be called "The Louise Harrison Collection" though I direct that if preferred by said legatee, all of the said contents of my said residences need not be included in one collection, but may constitute parts of different collections but in such event the articles bequeathed by me, <sup>shall</sup> be marked or labelled as having been given and bequeathed by me.

And the remainder of the contents of my said residences, I direct shall pass as part of my residuary estate, according as I (Louise Harrison) have hereinafter disposed of the same in case of my husband not surviving me, but I may, by a separate paper, designate certain articles not included in the above for persons to whom I direct my Executors shall deliver them,

Seventh: I direct that all the specific and pecuniary legacies given in this will, shall be paid and delivered by my Executors, free of any collateral or other inheritance tax, which may be due either to the State of Pennsylvania, or the United States, which tax or taxes I direct shall be paid out of the residue of my estate.

Eighth: All the rest, residue and remainder of my estate, real and personal, wheresoever the same may be situated, of which I may die seized or possessed, I give, devise and bequeath to my husband Thomas Skelton Harrison, absolutely and in fee simple, in case he survives me, but if my said husband, Thomas Skelton Harrison should not survive me, then I give, devise and bequeath all the rest, residue and remainder of my estate whatsoever and wheresoever the same may be situated, to Eliza H. Elliot, sister of my said husband, absolutely.

Ninth: It is my desire, and I so request my said husband, that during the life of my sister Marion L. Harvey, he should pay to her the sum of Fifteen hundred Dollars (\$1500.) per annum, but this request is not to bind my said husband, nor in any way effect his absolute title to all my real estate, which shall be held by him free and clear of any charge or lien by reason of this request.

Tenth: I nominate, constitute and appoint my said husband, Thomas Skelton Harrison, John Hampton Barnes and L. Harrison Dulles to be the Executors of this my last will and Testament.

I, Louise Harrison, wife of Thomas Skelton Harrison, of the City of Philadelphia, being of sound and disposing mind and memory, do make, publish and declare this Codicil to my last Will and Testament, bearing date the third day of June, A.D. 1913.

First: I direct that my tiara of diamonds, containing eighteen solitaire diamonds, shall be sold by my Executors, at either public or private sale, after my death, and the proceeds form part of my residuary estate.

Second: I give and bequeath all my jewelry, not mentioned in my last Will and Testament, unto my husband Thomas Skelton Harrison, for and during the term of his life, but without obligation on his part to enter security for the same, and upon his death I give and bequeath the following articles of jewelry to the following individuals and corporations:

My chain of One hundred and eighty-seven diamonds, to which is attached my face -a-main of exquisite workmanship in diamonds and platinum, to Eliza H. Elliot, for her life with remainder at her death to John Harrison, son of the late Charles Leland Harrison

A handsome gold watch with the initials "L.H." in diamonds and the Harrison crest, to Catharine Norris Harrison, to whom I also give one round brooch in diamonds and platinum.

One round brooch in diamonds and platinum to Marjorie Harrison Wife of H. Norris Harrison

One gold bracelet with diamonds and sapphires to Cecily Barnes, daughter of John Hampton Barnes.

One gold bag with pearls and diamonds to Dorothy Barnes daughter of John Hampton Barnes.

One ring set with pearls and one ruby ring encircled with diamonds to Sylvia Barnes daughter of John Hampton Barnes.

Two miniatures of my husband and myself to Eliza H. (Louise Harrison) Elliot, Absolutely.

The large blue scarab (which has been used as an eye-glass holder) surrounded with diamonds, rubies and emeralds, and also two Turkish zarfs, or coffee cup holders, given to me by Princess Fouad, I give and bequeath to the Pennsylvania Museum and School of Industrial
