

FIFTEENTH: If I died seized and possessed of the premises 1029 Broadway, Borough of Brooklyn, City of New York, I hereby empower and direct my executors hereinafter named, to sell said property as soon after my decease as in their judgment is wise and proper; and I direct that the proceeds therefrom be applied as directed in the succeeding paragraphs; but if I dispose of said property during my lifetime, then I direct that those same legacies be paid out of the sums remaining in my estate, as follows:

SIXTEENTH: Two Hundred and Fifty (\$250.00) Dollars to my cousin Moses Goldsmith, 329 Washington Avenue, Newport, Kentucky One Hundred (\$100.00) dollars to my brother-in law Abraham Honig who resides with his sister Mrs Carrie Cohn. One hundred (\$100.00) Dollars to my aunt Yetta Goldsmith, 419 East 79th Street, New York City.

Two Hundred (\$200.00) Dollars to my sister-in law Mrs Carrie Cohn, 220 East 20th Street, New York City.

One Hundred (\$100.00) Dollars to my nephew Irving Cohn, son of Mrs Carrie Cohn One hundred (\$100.00) Dollars to my nephew Henry Cohn, of 914 Jackson Avenue, Bronx Borough, also son of Mrs Carrie Cohn.

Two Hundred (\$200.00) Dollars to my Cousin Morris Steiner, of 167 Cooper Street, Brooklyn, New York.

One Thousand (\$1000.00) dollars to the Jewish Hospital Brooklyn, to endow a bed in my name.

SEVENTEENTH: I give and bequeath to my sister-in law Jennie Kodziesen, wife of Aaron my lace coat and my lace dress.

EIGHTEENTH: I give and bequeath unto my niece Hattie Kodziesen Baruch, of Port Chester, New York, my baby-lamb fur coat.

NINETEENTH: I give and bequeath unto my niece Myrtle Kodziesen, daughter of Abraham Kodziesen, my new seal fur-coat with Scotch mole.

TWENTIETH: I give and bequeath all the rest of my wearing apparel not specifically disposed of, to my brother Max Kodziesen.

TWENTY-FIRST: I give and bequeath all my household goods, silverware, linens, cut-glass and furniture to my brother Max Kodziesen, 850 Broadway, Brooklyn, New York.

TWENTY-SECOND: I give and bequeath all the rest of my jewelry not specifically disposed of to my sister-in-law Mrs Gussie Abraham Kodziesen.

TWENTY-THIRD: I hereby direct that all the rest, residue and remainder of my estate, including the proceeds from the sale of my real property hereinbefore mentioned, be divided into three equal parts; and I hereby give and bequeath one of such <sup>equal</sup> parts to each of my three brothers Abraham Kodziesen, of 631 Pitman Avenue, Brooklyn, New York, Aaron Kodziesen, of 302 West 87th Street, New York City, and Max Kodziesen of 850 Broadway Brooklyn New York, with the following exception:

TWENTY-FOURTH: Out of the equal share above bequeathed to my brother Max Kodziesen, I direct that he be paid outright the sum of One Thousand (\$1000.00) Dollars; and the balance remaining out of the equal part so bequeathed for my brother Max, I hereby give and bequeath to my executors hereinafter named, in trust, nevertheless, to invest and re-invest same and to collect the income and profits thereof, and to pay to my brother Max One Thousand (\$1000.00) Dollars a year until the principal sum thereof has been all paid to him, or until his death; and I direct that if my brother Max die before the entire one third part has been paid to him in the manner above indicated, that the residue thus left remaining, be divided equally among my surviving brothers or their legal representatives.

TWENTY-FIFTH: I hereby nominate and appoint as the Executors and Trustees of this my last will and Testament my beloved brothers Abraham Kodziesen and Aaron Kodziesen, and I

direct that they be not required to furnish bonds for the faithful performance of their duties
