

Item 8a. On the first anniversary of my death I desire that a memorial service in some large hall be held at which a first class string quartet shall be engaged, together with a really good soprano soloist, and that the following programme be played or sung:-

"The last Movement of the Prelude to the Hymn of Praise " by the quartet:

- "The Unfinished Symphony " Schubert.....
- "The Fire Music from Die Valkure" Wagner.

With Soprano solos interspersed with the above string instruments.

"Ave Maria" Gounod

"Lead Kindly light" and ending with "Onward Christian Soldiers" sung by the whole audience. AND before the singing is finished if my friends Thomas A. Daly, Doctor William S. Hughes and Joseph B. McCall are still living I would be glad if they could each give a talk of ten minutes. I direct that the members of the Poor Richards Club and the Canadian Society be especially invited and favored with good seats.

Item 9:- In finishing this my last will and testament I think it right to say that I have tried all my life to be of help to other people. My parents fortunately were born poor, both had good constitutions and therefore had the ability for hard work. They were healthy rugged and lived at the simple life with a kind word for all with whom they came in contact. They themselves became confined optimists and brought up a large family of twelve, six boys and six girls, of which four died in infancy. I was the eldest of the twelve, for myself, I inherited from them when they were in the springtime of their lives, not only a splendid constitution but a cheerful, happy disposition which no hardships or reverses have seemed to dissipate, and being so lavishly equipped by my parents it need not be marvelled at that my energies have ever been spent more to help others than myself. Of course this habit of practice has reacted upon me to such an extent that I can truthfully say that during the whole of my life I have been first a happy boy and next a happy man, and at times I have been (what I may be excused for saying)- radiantly happy. It is a great step forward in the career of any man or woman to have been born of healthy rugged and cheer parents. When I die I will leave this beautiful and interesting world believing in a merciful God as the maker and creator of the whole universe, and that what I may have done wrong will be censured and must be atoned for in some way unknown to mortals and what little I may have done that was right and worthy will be recognized, if not rewarded. To my mind the most deeply read or pious theologian cannot well believe or profess to believe very much more than is contained in this simple declaration.

Item 10. It is my will and for the purpose of carrying out the provisions hereof, I hereby authorize, empower and direct my executors and trustees, or the survivor of them, in the event of the principal of the present personal estate or any reinvestment thereof, being paid off or discharged to reinvest the same in good first mortgages on real estate bearing interest at not less than five per cent (5%) nor more than six per cent (6%) and in bonds of the higher class used for investment. I prohibit investments in business schemes or promotions of any kind except as contained in item 6 hereof; and to collect the incomes and profits and pay the same as heretofore ordered and directed. And I also authorize and empower my executors and trustees, or the survivor to grant, bargain, sell, convey and absolutely dispose of all my real and personal

estate either at public or private sale or sales as my said executors and trustees or the survivor, may deem best for the best price or prices that may be gotten for the same, and to sign, seal, acknowledge and deliver to the purchaser or purchasers thereof all assignments, transfers, deeds, assurances and acquittances in the law necessary to vest the title thereto in the purchaser or purchasers thereof in fee simple, free, clear and discharged of and from all trusts and limitations whatever without any liability on the part of the purchaser or purchasers thereof to see to the application of the purchase money.

Lastly. I hereby nominate, constitute and appoint my wife Rosie Martindale, my sons Thomas Crum Martindale and James Joseph Martindale and my friends George Nowland and William F. Breitenbaugh to be the executors and Trustees of this my last will and Testament directing that should there be any difference of opinion on their part upon any matters which may arise, that the same be settled by a majority vote among them.
