children who may be living at the time of my death as I shall not have given a awedding present prior to my decease.

Fifth. Ina smuch as each of my daughters, IDA NEWBURGER GUTMAN and CARRIE NEWBURGER LOEB received a wedding gift of Ten Thousand (\$10,000) Dollars from me, and each of my sons but Four Thousand Dollars (\$4,000) as a wedding gift, I give and bequeath to my sons, Samuel M. Newburger, Alfred H. Newburger, Frank L. Newburger and Lester M. Newburger the sum of Six Thousand Dollars (96,000) each.

Sixth: I order and direct that all the proceeds of my life insurance policies no matter in whose name the policies are written, shall be divided equally among my six children, Samuel M. Newburger, Alfred H. Newburger, Frank L. Newburger, Lester M. Newburger, Ida Newburger Gutman and Carrie Newburger Loeb. In the event of the decease of any of my children prior to my decease, such share of such deceased hild shall be divided equally among his or her surviving children.

Seventh: I desire my stocks, bonds and all other securities, together with such real estate as I may died possessed of, to be sold as soon as in the Judgment of my Executors they may deem practicable and advisable.

Eighth; Should Miss Jane Hoffman, my present nurse, survive me then I give and bequeath unto her the sum of Three Thousand (\$3,000) Dollars in appreciation of her devotion to me and of the careand attention received at her hands. I feel she deserves such recognition of her services. And if she is in my employ at the time of my decease, I direct that in addition to the Three Thousand (\$3,000) Dollars bequeathed to her as aforesaid, she is to receive and I give and bequeath unto her the sum of Five Hundred (\$500) Dollara for each and every year or part of a year that she is in my employ after January 1st, 1917 until the time of my decease.

Ninth: All the rest residue and remainder of my estate, real, personal and mixed, I give devise and bequeath to my six children, viz: Samuel M. Newburger, Alfred H. Newburger, Frank L. Newburger, Lester M. Newburger, Ida Newburger, Gutman and Carrie Newburger Loeb, absolutelty share and share alike. In the event of the decease of any of my children prior to my\_decease, the share to which such deceased child shall be entitled to under the terms of this will, shall be divided equally among the then living children of such deceased child. It is my urgent wish to my children that the division be made in harmony good brotherly and sisterly feeling and without grasping or acrimony.

Tenth For the purpose of paying my debts, for the distribution of my estate and for any other purpose, I hereby authorize my Executors and the survivor of them to sell and dispose of all or any part of the real estate/which I may die seized or possessed, either at public or private sale, for such prices and on such terms as may be deemed best by my said executors or the survivor of them, and by proper deed or deeds, conveyances or assurances in the law to be duly executed, acknowledged and perfected, to grant, convey and assure the same, or any part thereof, to the purchase or purchasers thereof, free from all liability to see to the application, mis-application or non-application of the purchase money.

Eleventh: I direct my executors not to file in any public office an inventory appraisement ar account of my property and estate, but an inventory appraisement and account thereof shall be made in some proper book under the direction of my Executors to preserve among the books and papers of my estate so that any and all persons having any interest under my will may have access thereto at proper and reasonable times.

Twelfth: I nominate constitute and appoint as Executors of this will my sons, SAMUEL M NEWBURGER, ALFRED H. NEWBURGER, FRANK L. NEWBURGER, and LESTER M. NEWBURGER, and order and direct that they shall not be required to give boond or security for the performance of their duties under the terms of this will. IN WITNESS WHEREOF, I MORRIS NEWBURGER, The Testator above named, have hereunto set my hand and seal this 21st day of February in the year one thousand nine hundred and seventeen (1917).
