Eleventh: I give and bequeath the sum of twenty-five dollars to the Rev. Peter J. Petri of Atlantic City, N. J.

Twelfth: I give devise and bequeath all the rest, residue and remainder of my estate either personal, real or mixed whatsoever it may consist of or wheresoever situate at the time of my death unto my beloved husband Michael Quinn, his heirs and assigns forever.

Thirteenth: I nominate, constitute and appoint my beloved husband, Michael Quinn executor of this my last will and testament.
