I, SUSANNAH E. NEAD, widow of William J. Nead, deceased, late of the City of Philadelphia, and daughter of the late William Amer, do hereby make, publish and declare this as and for my last will and testament, hereby revoking, except as hereinafter mentioned, all other wills I may have heretofore made.

First, I order and direct that all my just debts and funeral expenses be paid as soon after my death as possible.

Second, I direct that my Executors shall immediately upon my decease have thirty consecutive low masses said for the repose of my soul.

Third, I direct my Executors as soon after my decease as possible to expend the sum of Three thousand dollars for three thousand low masses for the repose of my soul, the said sum to be paid as follows, to whomsoever shall-be-pastor of the several churches in the City of Philadelphia, hereinafter named, the several sums hereinafter mentioned, All Saints Chapel, Blockley Almshouse, the sum of Twenty five dollars; the Church of the Epiphany, Eleventh and Jackson Streets, the sum of Twenty five dollars; Church of the Gesu, Eighteenth and Stiles Streets, the sum of Five hundred dollars; the Church of the Holy Family, Manayunk, the sum of Twenty five dollars; the Church of Our Lady Help of Christians, Allegheny Avenue and Gaul Street, the sum of Twenty five dollars; the Church of Our Lady of Lourdes, Sixty third Street and Lancaster Avenue, the sum of Twenty five dollars; the Church of Our Lady of Mercy, Broad Street and Susquehanna Avenue, the sum of Twenty-five dollars; the Church of Our Lady of Mt. Forty-eighth Street and Lancaster Avenue, the sum of Twansy-five dollars; St. Paul's, Tenth and Christian Streets, the sum of Twenty-five dollars; The James, Thirty state and Chastaut Streets, the sum of Tweety-fine Dellars; St. Elisabeth's. Twenty-third and Berks Streets, the sum of Fifty dollars; The Annunciation, Tenth and Dickinson Streets, the sum of Twenty-five dollars; St. Edward's Eighth and York Streets, the sum of Twenty-five dollars; The Church of the Most Blassed Sacrament, Fifty-sixth Street and Chester Avenue, the sum of Twenty-five dollars; St. Rita's Broad and Ellsworth Streets, the sum of Twenty-five dollars; Visitation of the Blessed Virgin Mary, Lehigh Avenue and B. Street, the sum of Twenty-five dollars; St. Stephen's, Broad and Butler Streets, the sum of Twenty-five dollars; Church of Our Lady of Blessed Sacrament, Broad Street and Fairmount Avenue, the sum of Twenty-five dollars; Sacred Heart of Jesus, Third Street below Reed Street, the sum of Twenty-five dollars; Our Mother of Consolation, Chestnut Hill, the sum of Twentyfive dollars; And to the following colleges the sums hereinafter mentioned; To The Holy Ghost Apostolic College, Cornwells, the sum of Three hundred dollars; the Augustinian College of St. Thomas, of Villanova, Villanova, Delaware County, Pennsylvania, the sum of Three hundred dollars; The College of the Priests of the Congregation of the Mission, the sum of Two hundred dollars.

Fourth, I direct that my funeral shall be conducted as follows: My body is to be enclosed in a mahogany casket with glass cover, metallic sealed, to have cedar or mahogany case outside similar to the manner in which I had my dear husband buried. The Oliver H. Bair Company, whom I employed for my husband's funeral, if in business at the time of my decease, shall be employed to conduct my funeral. I desire to be buried from the Church of the Gesu, Eighteenth and Stiles Streets, Philadelphia. As I directed for my husband's funeral a solemn requiem mass at the said Church of the Gesu, I direct that a like service be held at my funeral, and that my body be interred next to my dear husband, in the lot known as the "Nead" lot, in Cathedral Cemetery, Philadelphia, which lot by my husband's will is now vested in me. In preparing my body for the grave my wedding ring with the guard ring shall be buried with me. This ring was never removed in life, and I do not wish it removed in death. And after my body is interred the said burial lot shall be Wested in my Executors and the survivor of them with no power to sell or dispose of the said lot in any way whatsoever, but to hold said burial lot only for the purpose of keeping it in order forever. No right to the said lot or the use thereof shall become vested in any person by descent or otherwise, but said lot shall remain at all times as a sole resting place for myself and those who are now buried therein. By virtue of the power given me under the will of my dear father William Amer, and of all other rights which I possess, so far as I have the power so to do, I direct the Pennsylvania Company for Insurances on Lives and Granting Annuities, the Trustee named in my father's will, to hold the lot and vault in Laurel Hill Cemetery, where my dear father is buried for all time and permit no one other than my sister and her children and their immediate families to be buried therein. As I am interested in the lot in Cathedral Cemetery which belonged to my dear mother Mary Amer, in which my dear grandmother is buried, I direct that no other person shall ever be buried therein and that none of the bodies now buried in the said lot be disinterred or removed therefrom.
