KINGS COUNTY SURROGATE'S COURT

In the matter of the Petition of JOSEPH H. HAFNER to prove the last Will and Testament of LUCY M. HAFNER, late of the County of Kings, deceased.

To the Surrogate's Court of the County of Kings:

The petition of JOSEPH H. HAFNER, who resides at No. 608 Jefferson Avenue in the Borough of Brooklyn, City of New York, alleges that he is one of the Executors named in the last Will and Testament of Lucy M. Hafner, late of the County of Kings, deceased.

That the said deceased resided at the time of her death at No. 608 Jefferson Avenue and died at the County of Kings, City of New York on the 19th day of January, 1919.

That said last Will and Testament was made at Woodcliff, New Jersey and relates to both Real and Personal Property, and bears date the 12th day of March 1917 and was signed by Ethel S. Miller and J. Clarence Miller, both residing at Woodcliff, on-Hudson, New Jersey, as witnesses.

That the petitioner does not know of any other Will or of any Codicil to said Will, or of any instrument purporting to be such, nor is there any to petitioner's best information and belief.

That said deceased left her surviving a husband, Joseph H. Hafner, who resides at No. 608 Jefferson Avenue

That all the heirs at law and all the next of kin of said deceased are as follows, to wit:

Helen May Hafner, a daughter of deceased who resides at 608 Jefferson Avenue, Borough of Brooklyn, City of New York

Robert Joseph Hafner, a son of deceased who resides at 608 Jefferson Avenue, Borough of Brooklyn, City of New York.

That the names and post-office addresses of the legatees, devisees, executors, trustees and testamentary guardians named or described in the said will or any other will filed in the Surrogate's Office, Kings County, other than the persons named above and who are not heirs at law or next of kin of said deceased, are as follows:

Henry Clayton, brother of deceased Chatham, New Jersey, named as Executor in Will

That all the persons above named are of full age and of sound mind except Helen May Hafner, age ten years, and Robert Joseph Hafner, age twelve years, for whom no general guardian has been appointed.

That a citation issue hereinto the persons entitled thereto, citing them to show cause why such decree should not be made.
