BE IT REMEMBERED, That on the sixth day of November, A. D. nineteen hundred and fifteen, Emma N. Wright and Barton B. Hutchinson the Executors named in a paper writing, bearing date February 5th, A. D. 1913, and purporting to be the last Will and Testament of Horace G. Norton, deceased, late of the County of Mercer, and State of New Jersey, and codicils thereto, bearing date respectively, March 21st, A. D. 1913, and December 12th, A. D. 1913, appeared before the Surrogate of the County of Mercer, and made application to have the said Will and codicils proved; and on such application said Surrogate adjudged the said Will and codicils to be valid and the proofs thereof to be sufficient, which said last Will and Testament, and codicils, and the proofs thereof, are as follows, that is to say:

I, Horace G. Norton, of the City of Trenton, in the County of Mercer and State of New Jersey, being of sound and disposing mind, memory and understanding, (hereby revoking any and all wills and codicils heretofore made by me), do make and publish this, my last will and testament, in the manner following:

First- I order and direct that all my just debts and funeral expenses be fully paid and satisfied as soon after my decease as they conveniently can be, and that my executors hereinafter named cause to be erected in the burial lot where my remains shall have beeninterred, within one year after my decease, a suitable monument to the memory of my father, mother, brother, Elizabeth Duncan (mother of my wife), my wife and myself, the same to cost not less than one thousand dollars and not more than two thousand dollars.

Second- I give and bequeath to Union Industrial Home, now located on Chestnut Avenue in the City of Trenton, New Jersey, by whatsoever name it may be called or known in the law, the sum of two thousand dollars to be paid to it upon the decease of my wife, Emma A. Norton.

Third - I give and bequeath to Mary McKay, of Hightstown, New Jersey, lately the housekeeper for my now deceased brother, W. Irving Norton, the sum of five hundred dollars, to be paid to her upon the decease of my wife, Emma A. Norton.

Fourth: I give and bequeath unto Ella Van Horn, of the City of Trenton, New Jersey, now employed in my family as house-keeper, the sum of five hundred dollars, to be paid to her upon the decease of my wife, Emma A. Norton.

Fifth- I give and bequeath all medical supplies, medical and surgical instruments and office equipment for the practice of medicine or surgery of which I shall die Memorial possessed to William McKinely / Hospital, now located in the City of Trenton, New Jersey, by whatsoever name it may be called or known in the law.

Sixth- I give and bequeath to Mercer County Component Medical Society, by what soever name it may be called or known in the law, my medical and surgical library, and the sum of one thousand dollars to be paid to it upon the death of my wife, Emma A. Norton.

Seventh- I give and bequeath to East Windsor Cemetery, located in or near Hightstown in Mercer County, New Jersey, by whatsoever name it may be called or known in the law, the sum of two hundred dollars, to be held by it in trust and safely invested and kept invested at the current rate of interest and the net interest, income and proceeds arising therefrom to be used annually by said cemetery for the perpetual care and repair of the burial lot in said cemetery in which my remains or those of my wife, Rema A. Norton, shall be intered.

Eighth- All the rest, residue and remainder of my property and estate, real, personal and mixed, wheresoever found or situate, I give, devise and bequeath to my niece, Emma N. Wright, now living with me in the City of Trenton, New Jersey, and my friend and counsel, Barton B. Hutchinson, now of said city of Trenton, New Jersey, in trust, to sell, convey and convert the same or any part thereof, if in their sound discretion it may be necessary or advisable for the best interest of my estate, from time to time and at any time, and to inwest and keep invested the net proceeds thereof upon first bond and mortgage upon improved city real estate, to an amount not exceeding two-thirds of the fair market value thereof in any one case, at the best rate of interest that can be obtained, free and clear of taxes or other impositions, or in such securities as are allowed, at the time of such investment or investments, by the laws of the state of New Jersey to be made by trustees; and in further trust to pay at least semi-annually or quarterly, or monthly if possible, the net interest, income and proceeds arising therefrom, or so much thereof as may be necessary and in accordance with her station in life, to or for the use, benefit and support of my wife, Emma A. Norton, for and during the term of her natural life:

It is my will that my said trustees shall give and at all times maintain at the expense of my estate, a bond to the Ordinary of the state of New Jersey in the penal sum of double the amount or value of all money and personal property and proceeds of the sale of any real estate that shall come to or be in their hands or under their control, or in the hands or under the control of either of them, such bond to be approved, as to the form and security thereof, by the judge of the Orphans Court in and for the County of Mercer in the State of New Jersey or by the judge of the Prerogative Court in and for the State of New Jersey, and to be filed with the clerk of said court respectively.

If my said wife, Emma A. Norton, shall survive the said Barton B. Hutchinson, then I constitute and appoint his son, Charles Percy Hutchinson, to be his successor in said trust, subject to the aforesaid requirements and conditions, and if he or the said Barton B. Hutchinson should survive my said niece, Emma N. Wright, then I desire that some natural person be appointed by a court of competent jurisdiction in her place and stead, subject to the aforesaid requirements and conditions.

Ninth- Upon the death of my wife, Emma A. Norton, I give, devise and bequeath a three-fourths part of all the said residue and remainder of my property and estate, real, personal and mixed, wheresoever found or situate, and all accumulations and accretions thereof or thereto, to my niece, Emma N. Wright, to her, her heirs and assigns fore-ever, and the remaining one-fourth part thereof to be divided equally among my cousins by blood then living, share and share alike, to them, their heirs and assigns forever.

Lastly- I hereby constitute and appoint my niece, Emma N. Wright and my friend, Barton B. Hutchinson, executors of this, my last will and testament.
