I, Cecilia A. Hallahan, of the City of Philadelphia, do make this my last Will and Testament:-

First: I desire that all my just debts and funeral expenses shall be paid as soon as conveniently can be after my decease.

Second: I give and bequeath unto my husband, Peter T. Hallahan, any part or all of my household furniture or furnishings which he may desire, and also my automobile and any articles used in connection therewith.

Third: I give and bequeath to my brother, Francis McManus, if he shall be living at the time of my decease, the sum of fifteen hundred (\$1500.) Dollars, clear of taxes.

Fourth: I give and bequeath to my brother, Ambrose McManus, if he shall be living at the time of my decease, the sum of Five Hundred (\$500) Dollars, clear of taxes.

Fifth: I give and bequeath to Saint John's Memorial Chapel, (Roman Catholic), of Tryon, North Carolina, the sum of Five hundred (\$500) Dollars, clear of taxes.

Sixth: I give and bequeath to the Roman Catholic Archbishop of Philadelphia, the sum of One thousand (\$1000.) Dollars, to have masses said for the repose of my soul.

Seventh: I desire that my Executor hereinafter named shall deposit to the credit of John W. Hallahan, the 4th son of My Son Edmund P. Hallahan, the sum of Five (\$5.) Dollars per month until my said grandson shall arrive at the age of twenty-one years.

EIGHTH: I give and bequeath to my son, Edmund P. Hallahan, if living at the time of my decease, all of my silver and silver-plate, and also my complete set of Limoges china.

Ninth: All the rest, residue and remainder of my estate, real, personal and mixed, I give and bequeath to the Fidelity Trust Company of Philadelphia, IN TRUST, to pay the net income thereof annually to my son, Edmund P. Hallahan, for and during the term of his natural life, and upon his decease I desire the principal of said fund shall be divided equally between Saint Edmund's Home for Crippled Children, at 44th Street & Haverford Avenue, and the Catholic Home for Destitute Children, at 29th Street & Allegheny Avenue.

Tenth: I desire that any and all funds payable to any of the beneficiaries under this my last Will, shall be paid only to the party entitled thereto, on his, her or their own receipt, and shall not be liable for their debts or engagements, and shall not be anticipated, pledged or assigned in any manner whatever.

Eleventh: I give and grant my Executors hereinafter named full power to sell any and all real estate of which I may die seised, at public or private sale, without liability on the part of the purchaser or purchasers to see to the application of the purchase money.

Twelfth: I appoint my husband, Peter T. Hallahan, and the Fidelity Trust Company, Executors of this my last Will and Testament.
