TO THE SURROGATE'S COURT OF THE COUNTY OF KINGS:

THE PETITION OF HARRY G. HARRISON, who resides at No. 1310 Eighth Avenue in the Borough of Brooklyn, City of New York, alleges

That he is the Executor named in the last Will and Testament of Annie Harrison late of the County of Kings, deceased.

That the said deceased resided at the time of her death at No. 1310 Eighth Ave., Brooklyn, N.Y. and died at 1310 Eighth Ave., Brooklyn, N.Y. on the 10th day of May 1920.

That said last Will and Testament was made at the City of New York and relates to both Real and Personal Property, and bears date the 25th day of November 1919, and was signed by John J. Dooling and Julia Connolly as witnesses.

That the petitioner does not know of any other Will or of any Codicil to said Will, or of any instrument purporting to be such, nor is there any to petitioner's best information and belief.

That said deceased left her surviving a husband, the said Harry G. Harrison petitioner herein who resides at No. 1310 Eighth Avenue, Brooklyn, New York.

That all the heirs at law and all the next of kin of said deceased are as follows, to wit:

Margaret Rhatigan a sister of deceased who resides at No. 272 Sixth Avenue, Brooklyn, New York.

James F. Gillen a nephew of deceased who resides at No. 208 Clifton Place, Brooklyn, New York.

Peter Gillen a nephew of deceased who resides at No. 282 Nostrand Avenue, Brooklyn, New York.

Patrick Gillen a nephew of deceased who resides at No. 282 Nostrand Avenue, Brooklyn, New York.

Mamie SeEVERS a niece of deceased who resides at No. 1179 Decatur Street, Brooklyn, New York.

Alice Lovelock a niece of deceased who resides at No. 758 Marcy Avenue, Brooklyn, New York.

Katherine Graffe a niece of deceased who resides at No. 23 Crescent Place, Brooklyn, New York.

That the names and post-office addresses of the legatees, devisees, executors, trustees and testamentary guardians named or described in the said will or any other will filed in the Surrogate's Office, Kings County, other than the persons named above and who are not heirs at law or next of kin of said deceased, are as follows: None

That the said Annie Harrison had a brother James Patrick Reilly,

That after having used due diligence your petitioner is unable to ascertain whether the said James Patrick Reilly be dead or living and is unable to ascertain where, if living, he resides.

That it is a matter of knowledge to your petitioner as the husband of a sister of the said James Patrick Reilly, that the said James Patrick Reilly became a seaman many years ago and disappeared and has not been heard from by any members of his family for many years

That at the time of his disappearance, he was of full age, sound mind, had never been

married and was a citizen of Ireland,

That the only person whom your petitioner would think it likely to have any information concerning the said James Patrick Reilly is the only survivor of all of his brothers and sisters, namely, Margaret Rhatigan,

That she does not know whether the said James Patrick Reilly be dead or living or where, if living, he resides.

That all the persons above named are of full age and of sound mind.

That no petition for the probate of the said will or for letters of administration on the estate of the said deceased has been heretofore filed in this or any other Surrogate's Court of the State of New York, and that no other will of the said deceased has been filed in the Surrogate's Office of Kings County, except as hereinbefore mentioned and described.

That the value of the real property in the State of New York of which the said deceased died seized is no dollars and that the value of the personal property of which the said deceased died possessed is less than Sixteen hundred dollars.

That there are no persons interested in this application or proceeding other than those hereinbefore mentioned.

YOUR PETITIONER THEREFORE PRAYS:

That a decree be made admitting the said last will and Testament to probate as a will of real and personal property and that Letters Testamentary may be issued to the Executor who may qualify thereunder.

That a citation issue herein to the persons entitled thereto, citing them to show cause why such decree should not be made.

That an order be made directing that service of such citation upon the said James Patrick Reilly, brother of decedent, if living, and if he be dead, his executors, administrators, widow, issue, heirs at law and next of kin, whose names and places of residence are unknown and cannot be ascertained, be made by publication thereof in one newspaper, to-wit: published in the County of Kings, once week for four successive weeks and that the deposit in the post-office of any papers addressed to the said James Patrick Reilly, his widow, heirs at law or next of kin, be dispensed with.
