THIRD: I give and bequeath to my Trustees hereinafter named the sum of Five

Thousand Dollars (\$5000.00) to invest and keep the same invested in good and legal

securities and to collect the income and interest thereof and pay the same over semiannually to my granddaughter, Emma Morrison being the daughter of my son George W. Morrison
up to the time she arrives at the age of thirty-five (35) years; and as soon as she arrives
at such age, to pay over to her the principal. But in case she dies before she arrives
at the age of Thirty-five (35) years, then to any issue she leaves to survive her, in
equal shares. But should she die before she arrives at the age of thirty-five (35)

years, without leaving any issue her surviving, then the principal of such trust funds
to be paid over to my surviving children and the issue of any deceased child, such issue
to take per stirpes and not per capita.

FOURTE: I give and bequeath to my son, George W. Morrison, the sum of one thousand dollars (\$1000.00) absolutely.

FIFTH: I give and bequeath to my daughter, Laura V. Robison, the sum of five hundred dollars (\$500.00) absolutely.

SIXTH: I give and bequeath to my son, Jessie B. Morrison, the sum of five hundred dollars (\$500.00) absolutely.

SEVENTH: All the rest, residue and remainder of my estate, real, personal and mixed, whatsoever and wheresoever the same may be at the time of my_decease, I direct shall be divided into six equal parts, and one of such parts I give devise and bequeath to my Trustees hereinafter named to invest and keep the same invested and collect the interest and income thereof and pay the same over semi-annually to my son, William T. Morrison Jr., as long as he shall live; and immediately after his death the principal of said trust shall be divided as follows: One-half thereof shall go to the daughter of the said William T. Morrison, Jr., if she is living and of the age of thirty-five (35) years; or if deceasedand leaving -- issue her surviving, then the said one-half shall go to such issue; but if she should be dead without leaving issue, then it shall be divided in the same way that I direct the balance of one-half of said trust to be divided, and the other one-half shall be divided amongst my surviving children and my granddaughter, Emma Morrison, or the issue of any deceased child, such issue to take per stirpes and not per capita. Provided my said surviving children shall have reached the age of thirty-five (35) years, and if they shall not have reached the age of thirty-five (35) years, to hold their share in trust until they shall have reached that age, and then to pay over the principal to them absolutely.

One other of said parts I give, devise and bequeath to my son Frank W. Morrison and his heirs absolutely.

The other four-sixths (4/6) of my said residuary estate I give and bequeath to my trustees hereinafter named to invest and keep the same invested in good and safe securities and to collect the income and interest thereof and pay the same over every six months to my daughter, Emma Mars, and to my granddaughter, Emma Morrisen, being the daughter of my son George W. Morrison, so, however, that neither the principal nor the income of the said trust estate shall be assignable or subject to an attachment or execution or any debt or ebligation of theirs or either of them or subject to any demand of any husband

either one of them may now have or may hereafter take; and the receipt of the cestuique trust shall alone be received by my trustees for the income.

Upon the death of my daughter, Emma Mars I direct that the principal of one-half of said trust estate shall be paid immediately to any issue of my said daughter, her surviving in equal shares. But if my said daughter should die without leaving issue her surviving, then the said one-half of said trust estate shall be distributed in equal shares to my surviving children and the issue of any deceased child or children, such issue to take per stirpes and not per capita.

And upon the death of my granddaughter. Emma Morrison, I direct that the other one-half of the principal of my said trust estate shall be paid to and equally distributed to her surviving children or the issue of any deceased children, such issue taking per stirpes and not per capita. And should she die without leaving children or issue her surviving, then I direct that the said principal of the said one-half of my trust estate shall be paid over to my surviving children or the issue of any deceased child, such issue to take per stirpes and not/per capita.

EIGHTH: I hereby nominate, constitute and appoint

my sons, William T. Morrison Jr., and Frank W. Morrison to be the Executors and Trustees of this my Will.

LASTLY: I hereby direct my trustees and Executors to employ as counsel in the settlement of my estate, and in the subsequent management of the trust, my attorney, John Weaver, of the City of Philadelphia.
