Fifth.

I give and bequeath to my daughter Catharine all my house hold furniture of Second every kind and description.

I give and bequeath to the Revered Arthur J. Donnelly the sum of Two hundred Third dollars.

Fourth I give and bequeath to my

Executors the sum of Ten thousand dollars (\$10,000) in trust to them or such of them as shall qualify their survivors or survivor as follows To invest and Keep the same invested in bonds secured by mortgages on unencumbered real estate in the City of New York of double the value of the sum or sums secured thereby, interest to be payable semi-annually all mortgages to contain the usual interest tax and assessment and (when the mortgage is on improved property) insurance clauses or in stocks or bonds of the United States or of the State or City of New York to collect the interest thereon and after payment of all necessary expenses to pay over the net income of said sum of Ten thousand dollars to my daughter Catharine McCabe during her natural life for her sole and only use and benefit and thereafter to pay the said principal sum to such person or persons, institution or institutions as my said daughter by instrument in the nature of a last Will and Testament shall direct or in default of such testamentary disposition to pay the said principal sum to her lawful

I give and bequeath to my executors the sum of Ten thousand (10,000) dollars in trust to them, or such of them as shall qualify the survivors or survivor of them as follows - to invest and keep the same invested as hereinbefore provided to collect the interest thereon and after payment of all necessary expenses to pay over the net income of said Ten thousand dollars to my son Edward Mc Cabe for and during his natural life for his sole and only use and benefit and thereafter to pay the said principal sum of Ten thousand dollars to his lawful issue share and share alike or in default of such issue to my remaining children Catharine and Mary Ann or their issue share and share at the and iscase of the cheule se deceased without issue the neto the survivor

or her issue.

Out of the rest residue and remainder of my estate I give and bequeath Sixth to my daughter Catharine the sum of Two thousand dollars to bear interest from the date of my decease.

Out of the rest residue and remainder of my estate I give and bequeath to my Seventh executors or such of them as shall qualify the survivors or survivor of them the sum of Two thousand (2000) dollars in trust to invest and keep the same invested in the manner hereinbefore provided investing all interest received thereon after deducting necessary expenses as soon as possible and on the attainment of the age of Eighteen years by my granddaughters Mary Elizabeth Kelk and Catharine Kelk respectively to pay to each of them the one half of such sum together with all interest accrued thereon or in case of the death of either of my said grandchildren before attaining the age of Eighteen I direct the whole of said sum of Two thousand dollars with accumulations to be paid to the survivor on her attaining that age and in ease neither shall attain that age then upon the death of the survivor the said sum of

Two thousand dollars with all /accumulations to be divided equally between my three children Catharine, Mary Ann and Edward or their descendants per stirpes and not per capital.

Out of the rest residue and remainder of my estate I give and bequeath to the Eighth . Reverend Arthur J. All the rest residue and Ninth remainder of my estate of whatever nature I give devise and bequeath to my three children Catharine. Mary Ann and Edward to be divided equally among them.

I nominate and appoint my son Edward and my daughters Catharine and Mary Tenth Ann to be the Executors of this my last Will and Testament hereby revoking all other and former wills by me at any time made.
