SIXTH: I give and bequeath to my grandniece, MILDRED A. HALE, my sewing machine with all the attachments, the Brussels carpet on my dining-room floor and one small fork, one sugar spoon, one butter knife, one soup spoon and two tablespoons from my solid silverware.

SEVENTH: I give and bequeath to my grandniece, ELSIE BEATRICE HALE, my gold watch and chain.

EIGHTH: I give and bequeath to my grandniece, ETHEL A. HALE, six teaspoons, two tablespoons and one dessert spoon from my solid silverware.

NINTH: I give and bequeath to my grandniece, HELEN H. INGALLS, six teaspoons, two tablespoons, one dessert spoon, one sugar spoon, one small fork and one butter knife from my solid silverware.

TENTH: I give and bequeath to my grandniece, ADA ELOISE HALE, six silver plated soup spoons.

ELEVENTH: I give and bequeath to my grandniece, THELMA HALE, my silver plated cup and saucer.

TWELFTH: I give and bequeath to my niece, LAURA M. DIETRICH, six teaspoons from my solid silverware and the small marble top table which formerly belonged to her Grandmother Ingalls.

THIRTEENTH: I give and bequeath to my niece, LUCRETIA M. BEWLEY, my napkin ring marked with "L", the same having belonged to her Grandfather Ingalls.

FOURTEENTH: I give and bequeath to my niece, HELEN M. PIEZ, my napkin ring marked with "H", the same having belonged to her Grandmother Ingalls.

FIFTEENTH: I give and bequeath to my niece, ELOISE I. REILEY, all of my plated silverware not otherwise herein disposed of, my pearl and diamond pin, my pieces of old china and my gold clock.

SIXTEENTH: I give and bequeath to my grandnephew, WILLARD M. REILEY, five plain silver teaspoons in memory of his father (the same to remain in his mother's care until he has use for them) and also my book-case.

SEVENTEENTH: I give and bequeath to my niece, FLORA HART INGALLS, my small baroque pearl pin, my gold cuff pins and my gold pin of four linked rings.

EIGHTEENTH: I give and bequeath to my nieces, ELOISE I. REILEY and ETHEL I. HALE, all magazines and books not wanted by any member of my family, also all old muslins and linens, with the request that they give them to a hospital.

NINETEENTH: I give and bequeath to my niece, ETHEL I. HALE, all my floor coverings except the Brussels carpet hereinabove bequeathed.

TWENTIETH: All the rest, residue and remainder of my estate, real, personal and mixed, of every kind and nature whatsoever and wheresoever situated, I give, devise and bequeath to my three nephews, HENRY R. INGALLS, EDWARD W. INGALLS and WENDELL P.

INGALLS, and my five nieces, ETHEL I. HALE, ELOISE I. REILEY, LAURA M. DIETRICH, LUCRETIA M. BEWLEY and HELEN M. PIEZ, share and share alike, or in the case of the death of any one of them before me, to his or her issue the share the parent would have received, per stirpes and not per capita.

TWENTY-FIRST: I hereby appoint my esteemed and worthy friend, JOHN M. BEWLEY, to be the executor of this my last Will and Testament and direct that no bond or bonds shall be required of him, any law to the contrary notwithstanding.

TWENTY-SECOND: I hereby authorize and empower my said executor to sell and convey, at public or private sale, all or any part of my real estate not herein specifically devised, and to distribute the proceeds of such sale or sales in the manner above described.

TWENTY-THIRD: In order to assist my said executor in disposing of my personal effects, furniture and household goods, which form a part of my residuary estate, I direct that the same shall be divided, after careful consideration as to where they would be most needed, by my two nieces, Eloise I. Reiley and Ethel I. Hale, and distributed by them among my said nephews and nieces named in paragraph "Twentieth" hereof. I direct that no public auction shall be made of said effects, but I am willing that my executor shall sell at private sale such of my goods as he shall see fit. I prefer that my goods be consigned to the flames rather than be sold at public auction.
