Campbell and the same so made, do exhibit or cause to be exhibited into the registry of the Prerogative Court in the Secretary's Office of this State or into the Surrogate's office of the County of Atlantic, at or before the expiration of three calendar months from the date of the above written obligation, and the same goods, chattels and credits, and all other goods, chattels and credits of the said deceased at the time of her death which at any time after shall come into the hands or possession of the said Howard L. Campbell or into the hands or possession of any other person or persons for the said Howard L.
