Consent of widow to sale clear of dower.
To Honorable Enoch A. Higbee, Judge of the Orphans Court of the County of Atlantic.

Whereas, on the twentieth day of November, 1906, I was duly appointed by the Surrogate of Atlantic County the guardian of Mildred Blackman, only surviving child of my deceased husband, John Blackman, Jr., who at the time of his decease was seized in fee of the following described lands and premises, situate in the Borough of Somers Point, in the County of Atlantic and State of New Jersey: Beginning at a point in the northwest line of the main shore Road, leading from Somers Point to Absecon, and at the northeast corner of a lot of land owned by Samuel E. Decree for Sale.

I, appearing to the Court from the petition of Fannie Newell, Guardian of Mildred Blackman, a minor, that the said ward is of tender years, to wit, the age of four years; that she is dependent for her education and maintenance entirely upon her own estate and has no other proper means of support; and it further appearing that the said ward has no personal estate, and that the rents and profits of the real estate of said ward are not sufficient for her maintenance and education and the Court having made a full investigation of the estate and circumstances of said ward, and adjudged it to be necessary that all of the said lands of said ward should be sold for her maintenance and education. And it further appearing to the Court that Fannie Newell has her right of dower in said real estate and that she has consented in writing to a sale of the real estate of said ward free and discharged of her rights as dower and that she has agreed in writing to accept the gross sum of One hundred and Fifty dollars in lieu thereof.
