I was born in Montastruc, France, on the 21 day of Oct, anno Domini 1873; I now reside at Pancoast Mill N.J. I emigrated to the United States of America from Paris France on the vessel Rotterdam; my last foreign residence was Montastruc France.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to The French Republic, of which I am now a citizen subject; I arrived at the port of Portland Maine, in the State of Maine on or about the 25 day of Sept, anno Domini 1897; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
