I was born in Hilliges, Denmark, on the 20th day of Sept, anno Domini 1869; I now reside at 2035 Atlantic Ave Atlantic City, N.J. I emigrated to the United States of America from Southampton, England on the vessel City of Paris; my last foreign residence was Hilliges, Denmark.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Frederick VIII King of Denmark, of which I am now a citizen-subject; I arrived at the port of New York City, in the State of New York on or about the 10th day of May, anno Domini 1912; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas II Emperor of all the Russias, of which I am now a citizen-subject; I arrived at the port of New York City, in the State of New York on or about the 9th day of April, anno Domini 1909; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
