Maryland Ave Atlantic City, N.J. I emigrated to the United States of America from Bremen Germany on the vessel Kaiser Wilhelm der Grosse; my last foreign residence was Jassy Roumania. It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Charles King of Roumania, of which I am now a citizen subject; I arrived at the port of New York City, in the State Territory of New York on or about the 14th day of Dec., anno Domini 1904; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
