I, Joseph Kaplan, aged 26 years, occupation minister, do declare on oath that my personal description is: Color white, complexion light, height 5 feet 8 inches, weight 130 pounds, color of hair light brown, color of eyes grey, other visible distinctive marks none;

I was born in Lida Russia, on the 20th day of March, anno Domini 1886; I now reside at 1103 Bowen Terrace Atlantic City, N.J.

I emigrated to the United States of America from Liverpool England on the vessel Ivernia; my last foreign residence was Lida Russia.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas II Emperor of all the Russias, of which I am now a citizen subject; I arrived at the port of Boston, in the State Mass on or about the 5th day of June, anno Domini 1906. I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
