I was born in Aintab Turkey on the 27th day of May, anno Domini 1882; I now reside at 1032 Boardwalk Atlantic City N.J. I emigrated to the United States of America from Naples Italy on the vessel Rocka Kousta; my last foreign residence was Aintab Turkey. It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Mohammed V Sultan of Turkey, of whom I am now a subject; I arrived at the port of New York City, in the State of New York, on or about the 28th day of Febry, anno Domini 1910; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
