I was born in Snovskij Russia on the 9th day of June, anno Domini 1885; I now reside at 131 S. Kentucky Ave. Atlantic City, New Jersey (Give number, street, city or town, and State.)

I emigrated to the United States of America from Liban Russia to Quebec Canada on the vessel Altonia; my last foreign residence was Snovskij Russia.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas 2nd Emperor of all the Russias, of whom I am now a subject; I arrived at the port of Philadelphia by rail from Quebec Canada in the State of Pennsylvania, on or about the 19th day of May, anno Domini 1913; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
