I emigrated to the United States of America from Liverpool England on the vessel Carpathia; my last foreign residence was Berkshire England; I am married; the name of my wife is Margaret Simms; she was born at Flintshire England and now resides at Egg Harbor City, New Jersey

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to George 5th King of Great Britain and Ireland, of whom I am now a subject;
