I emigrated to the United States of America from Quebec Canada on the vessel Automobile; my last foreign residence was Quebec Canada; I am — married; the name of my wife is Leques Ridgen; she was born at Windsor Canada and now resides at Amater New Jersey. It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to George 5th King of Great Britain and Ireland of whom I am now a subject; I arrived at the port of St. Albans Vermont in the State of Vermont, on or about the 12th day of October, anno Domini 1915; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
