I emigrated to the United States of America from Russia on the vessel ...; my last foreign residence was Rief Russia; I am married; the name of my wife is ...; she was born at Rief Russia and now resides at 108 South Georgia Ave Atlantic City, N.J. It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Present Government of Russia, of whom I am now a subject;
