Free-trade is getting in its deadly work in the United States. Whereas in the ten months ended with April, 1915, the imports into the United States were valued at \$1,774,186,749, in the first ten months ended with April, 1916, the imports were valued at \$1,772,968,115.

Comparatively few of the industrial plants of Europe have suffered physical harm from the war. Given men to perform the work, capital to work with, and these establishments will soon be producing their wares at as high a rate as prevailed in the pre-war period.

When the war has ended the owners of these industries will be prepared to accept lower returns on their investments. If only because they must do so in order to recover lost trade. Wages are likely to be lower. With material reductions in the cost of manufacturing goods, the European industries can re-enter the world's markets with every faith of capturing them.

Industrial efficiency is the keynote of military success in Europe, and no nation there could survive without protecting and developing its industry against industrial labor. Protective tariffs are employed to protect industrial efficiency. England, once the stronghold of Free-Trade, is now virtually on a protection basis, while Germany's industrial efficiency is the direct outcome of a protective policy.

The war started the revival of industry in the United States. Most certainly when we began to feed the guns and the war in the armies of Europe there was coincident the revival of American industries of peaceful kind. But out of the war chaos was the life blood of our prosperity. Of course, the American workmen have more dollars now. But they have them in spite of the Democratic Underwood act, was destructive of American industry, and was a direct cause of the war.

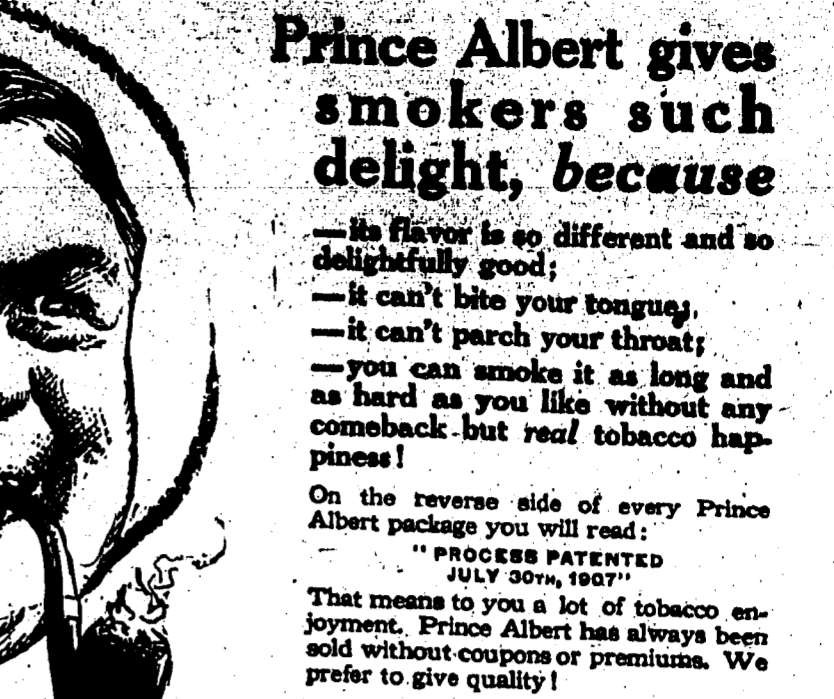
