Inland Waterway Marked.
The Department of Inland Waterways announces that the marking of the route of the Inland Waterway from Bay Head to Cape May has been completed. Three kinds of markings have been employed.
First—Black and white mid-channel barrel buoys where the channels are wide and deep.
Second—Beacons made of painted nail kegs set at important angles. In going South or entering port of Cape May, buoys red beam to starboard and black beam to port for the entire route.
Third—Brush-pile color stakes with red or black string attached, similar to harbor marks, are set on both sides of the channel in the shoal waters.
To avoid the crossing of Great Egg Harbor Inlet (Loupport to Ocean City) the channel has been marked in Ribley Channel, South Bay and Broad Thimble.
