It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to George V King of Great Britain & Ireland, of which I am now a citizen subject; I arrived at the port of New York City, in the State of New York on or about the 7th day of July, anno Domini 1902; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
