I was born in Rosso Russia on the 15th day of July, anno Domini 1881; I now reside at 203 N. S. Carolina Ave. Atlantic City New Jersey (Give number, street, city or town, and State.) I emigrated to the United States of America from Southampton England on the vessel St. Paul (If the alien arrived otherwise than by vessel, the character of conveyance or name of transportation company should be given.); my last foreign residence was Rosso Russia.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas 2nd Emperor of all the Russia, of whom I am now a subject; I arrived at the port of New York City, in the State of New York, on or about the 17th day of November, anno Domini 1907; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
