## Just Before The Battle.

Doubtless many of our citizens do not intend to vote next Tuesday, declaring that "there is no choice" between the candidates on the tickets; but let us express our views. We have several good men, against whom no one can point a finger of reproach, several of whom we have known for about thirty years.

For Mayor, John M. Austin; he is a clean, progressive, and popular young man, has served acceptably on Town Council, and would prove a straight Executive.

For Councilmen, Charles A. Wood, Robert H. Sharpe, Edw. H. White, and Daniel M. Ballard. With these four men in charge of our affairs—with Jas. V. Baker and John Dilger, hold-overs—we believe Hammonton would improve in every desirable way—in improvements, morals, and the enforcement of law. (The present Council made a good start.)

For Freeholder, Messrs. Jackson and Osgood are running very close; and as both are experienced in that office, and we believe neither one to be a "gangster," the choice is for the voters to make,—not we.

The other offices are, as one voter put it, "six of one and a half-dozen of the other." There seems to be more of a contest over the position of Constable than the best-paying job—that of Overseer of Highways. Messrs. Burgess and Bernhouse are after the latter office, Bernhouse having a good fighting chance,—C. C. Combes having withdrawn.

As to the appropriations, they should be voted straight, without a scratch.

Now a word to voters: Do not shirk your duty next Tuesday; step up and elect the men who, in your opinion, would be a benefit to the town and its people.

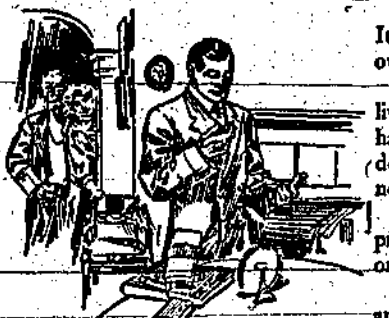

What shall we do with these enemies? This Book contains the evangel of Jesus, which tells three things. It says that the Lord of glory has dealt with the past, the present and to-morrow, and transform them all. It is worth listening to. It says we can be forgiven. The word translated "forgiveness" is a fisherman's word, very familiar to John and Peter, when Peter's boat was fastened to the beach by a rope he would tell his colleague to "loose the boat and set her free, and he would tell the word out used when he said "forgiveness." ## CONSERVING TIMBER SUPPLY.

One acre of Forest Land Needed for Each Citizen.

According to a bulletin issued by the Forest Service, there is at present an unfortunate lack of authoritative scientific information regarding the production, either natural or artificial, of American forests, to their growth, and to the best time and methods of cutting them, the New York Post says.

The "United States has been so richly endowed with natural resources that the thought of conserving our woods has come late. We have been unavailingly ignorant and therefore excessively heedless. By a careful conspectus made within the last two years of all the wooded area of the country, it has been learned that our total stand of timber is now between 1,500,000,000 and 2,000,000,000,000 feet. In a case of years' consumption has been doubling on population, and timber prices have shot up.

Mr. President, Madison's day—the States east of the Mississippi comprised over 1,000,000 square miles, or 700,000,000 acres. To-day there are not over 300,000 square miles, or 210,000,000 acres of merchanable forest left in this section. At present about 21 per cent of our lands is devoted to agriculture, a half century hence it will probably be 50 per cent.

"We had 113,000,000 acres in farms in Lincoln's day. We have 415,000,000 to-day. For each citizen there is required one acre of our lands. In the coming years, the United States is to be self-maintaining as regards its timber supply. At present each citizen has seven and three-fourths acres to draw from, but in truth he is actually drawing from an accumulated surplus of fifteen acres per inhabitant. At this rate we face a timber famine in a comparatively few years.

"Our national forests form only about one-fifth of our wooded lands, four-fifths being private forests, and, therefore, the law of the general principle of forestry understood and practiced. This endowment will help materially toward actual conservation of our wooded area and refuting of those already laid waste."

That the voters and other citizens of Hammoncton may know the true facts, I have decided to make this statement.  
Mr. Nicolai has left it to be inferred that I have stated that he made me an offer of two hundred dollars to vote for the DiGiacomo license. He never made the offer, nor did I ever say he had. He came to my home and asked me how I felt about granting the license. Without answering, I asked whether money was to be used to get it through. His answer was, "Yes, if necessary." I told him it was the case. I would not vote for it. If Mr. Nicolai was not prepared to make me an offer, why did he state that money would be used if necessary?

Later on, he was induced to vote for it on the strength of a petition, which afterward we learned had been circulated by a then member of Council. Within the past five months, Councilman Baker was approached and a direct offer of two hundred dollars made to him for a favorable vote.  
Mr. Nicolai, in the REPUBLICAN, makes an excuse for calling on me, that he had built that large building. If he is elected Councilman, and it should be his good fortune to be the builder of another big building, I hope he will not consider it his duty to try to get a license for it simply because he was the builder.  
There is one other very large rumor floating around town,—that if a favorable Council is elected next Tuesday, an effort will be made to have an Excise Commission appointed, which will, of course, be three eminent Hammoncton voters, and cost the Town \$450 a year. This will also deprive the Town of any control over the liquor business, putting it into the hands of the County Court. If this is done, how long will it be ere the same Sunday selling will be carried on here as is now done in Atlantic City, in defiance of law, where it has been found impossible to convict offenders.
